

#### Work Begins Soon at Goehner I-80 Interchange

Work is scheduled to begin around October 12 at the I-80 Interchange at Goehner, according to the Nebraska Department of Roads.

Herbst Construction Company, Inc. of Le Mars, Iowa, has the \$62,567 contract for rehabilitation of the L80G bridge over I-80. Work includes repairing abutments, joints, approaches, wing walls and deck work. Bridge traffic will be reduced to one lane with an 11 foot width restriction. A temporary traffic signal will be installed at the bridge site. Work on this project is anticipated to be completed in November.

The Nebraska Department of Roads will hold a public information meeting about improving Nebraska Highway 4 from Plymouth to Beatrice.

Personnel from the department will be available to visit one-on-one about the proposed project, identified as S-4-6(112) and known as the *N-4 Corridor Study*.

The corridor study includes two alternatives for future relocation of a portion of Nebraska 4, so the two-lane highway no longer will go through the Homestead National Monument Park.

One alternative under consideration would move the highway ½ mile north of the monument. The other alternative proposes moving the highway 1 mile north. Upon construction of the new alignment, a portion of the old Highway 4 would be relinquished to Gage County.

Construction would include roadside grading from Plymouth to the junction with U.S. Highway 136 at Beatrice, adding surfaced shoulders to that 12 mile stretch of Nebraska 4, and resurfacing the driving lanes.

Additional right-of-way property acquisition would be required throughout the length of the project in Jefferson and Gage Counties. Construction would impact wetlands areas and mitigation would be required.

The purpose of the information meeting is to receive public input for the study. Displays will be available for inspection, and NDOR personnel will receive comments and questions. No formal presentation is planned.

The Nebraska Department of Roads along with the State Highway Commission will hold a public hearing regarding improvement of 6 miles of U.S. Highway 281 in Webster County.

The proposed project south of Red Cloud involves roadside grading, asphalt surfacing, bridges, culverts, and some curb and gutter, while proposed work in town includes resurfacing, roadway lighting, curb and gutter, storm sewer and sidewalk. The project is identified as STPD-STPB-281-1(112), also known as Red Cloud South.

The project begins just south of the Nebraska State Line and ends in Red Cloud just south of 3<sup>rd</sup> Avenue. U.S. 281 one-on-one regarding the proposed will be milled and resurfaced. The completed two-lane highway will feature 8foot-wide surfaced shoulders.

A new bridge will be constructed over the Republican River on the existing highway alignment. The old bridge, which is listed on the National Register of Historic Places, will be moved just east of the existing alignment to carry traffic during construction of the new bridae.

Private property must be acquired for highway right-of-way throughout most of the project. Roadside widening will impact the Willa Cather Memorial Prairie, which is listed in the National Register of Historic Places. The access road to the historic marker and lookout will be surfaced as part of the project.

Roadside widening will impact a portion of the Indian Creek State Wildlife Management Area. In Red Cloud, the one-block-long Webster Street must be closed for safety.

Realignment of two segments of Cedar Creek will be required. Construction will impact wetlands areas and mitigation will be required. The department intends to establish replacement wetlands for about 2.5 acres on

public right-of-way along the project or at the Mormon Island Bank Site along the Platte River in Hall County.

Most of the highway project will be constructed under traffic. For about two weeks, through traffic will be detoured while the existing Republican River bridge is relocated for use as a temporary road. The detour will carry traffic via U.S. Highway 136, Nebraska Highway 78, Kansas Highway 128 and U.S. Highway 36.

The public hearing is being held to provide information about design features of the project. All people are invited to attend and present relevant comments and questions.

The public is invited to stop at the hearing location from 3 - 5 p.m. for an informal discussion of any aspect of the project.

Personnel from the Department of Roads will be available to visit improvements.

Written statements and exhibits may be presented at the hearing, and they will be accepted as part of the public record for 10 days after the hearing.

#### Nebraskans Urged to "Put the Brakes" on Traffic Fatalities

October 10 is the fourth annual "Put the Brakes on Fatalities Day." The Nebraska Department of Roads joins national safety organizations as they draw attention to the nation's high rate of traffic fatalities, about 42,000 per year, or 116 fatalities each day – one fatality every 13 minutes. The day is intended to heighten awareness about what can be done to stop fatalities by focusing attention on individual behaviors, with the goal of achieving one day of zero traffic fatalities across the nation.

Fewer people were killed or injured on U.S. highways last year – 42,643 – down 362 from the previous year. The decline was attributed to an increase in seat belt use and a decrease in accidents involving drunken drivers.

In Nebraska, 293 people died on the roads last year, 4.6 percent fewer than the 307 fatalities reported in 2002. One crash occurred every 11 minutes, 60 persons were injured each day and one person was killed every 30 hours. The economic loss for the state totaled \$1,868.979,100.

Last year on October 10, no fatalities were reported on Nebraska's highways, and there were 15 days in October with no fatalities. October 2003 had 36 traffic fatalities, compared to 31 deaths in October of 2002.

According to Randy Peters, NDOR Traffic Engineer, "Even one highway fatality is too many. We want to use this day to draw attention to the seriousness of this issue and to remind drivers that several simple steps can make a big difference. Wear your seat belt and don't exceed speed limits. Also, don't drive while impaired and don't get into the car with an impaired driver. Discuss this issue with your teenagers."

Peters noted that there have been many technological advances in developing safer vehicles and in making the roadway environment as safe as possible. But the main focus is still the choices each of us makes when using the roadways – as drivers, pedestrians, motorcycle and bicycle operators and passengers.

Following the theme of "drive as if your life depends on it" people are also asked to drive courteously and defensively, to know the rules of the road for the planned mode of transportation and to obey all signs and signals. The meeting is open to the public.



#### Public Hearing November 9 for Hwy. 281 Improvements in Red Cloud Area

The Nebraska Department of Roads and the State Highway Commission will hold a Public Hearing Tuesday, November 9, regarding improvement of six miles of U.S. Highway 281 in Webster County. The hearing will be held at 7:30 p.m., at the Community Building, 142 West 3<sup>rd</sup> Avenue, in Red Cloud.

The proposed project south of Red Cloud involves roadside grading, asphalt surfacing, bridges, culverts, and some curb and gutter, while proposed work in town includes resurfacing, roadway lighting, curb and gutter, storm sewer and sidewalk.

The project begins just south of the Nebraska state line and ends in Red Cloud just south of 3<sup>rd</sup> Avenue. A new bridge will be constructed over the Republican River on the existing highway alignment. The old bridge, which is listed on the National Register of Historic Places, will be moved just east of the existing alignment to carry traffic during construction of the new bridge.

Private property must be acquired for highway right-of-way throughout most of the project. Roadside widening will impact the Willa Cather Memorial Prairie, which is listed in the National Register of Historic Places. The access road to the historic marker and lookout will be surfaced as part of the project.

Roadside widening will impact a portion of the Indian Creek State Wildlife Management Area. In Red Cloud, the one-block-long Webster Street must be closed for safety.

Realignment of two segments of Cedar Creek will be required. Construction will impact wetland areas and mitigation will be required.

Most of the highway project will be constructed under traffic. For about two weeks, through traffic will be detoured while the existing Republican River Bridge is relocated for use as a temporary road.


